IN FY19, CHMO'S GENESIS SHELTER PROGRAM PROVIDED SHORT-TERM SHELTER AND CASE MANAGEMENT SERVICES TO 151 YOUTH AGES 16-21. THESE YOUTH, DURING AN AVERAGE STAY OF 23 DAYS, PARTICIPATED IN LIFE SKILLS CLASSES, TREATMENT PLANNING, AND ONGOING SUPPORT SERVICES. YOUTH WORKED WITH THEIR CASE MANAGERS TO DEVELOP GOALS AND IDENTIFY SAFE AND STABLE DESTINATIONS TO GO UPON LEAVING THE SHELTER.

THROUGHOUT FY19, 72% OF THESE YOUTH WERE WORKING, IN SCHOOL, OR ACTIVE IN OUR CAREER READINESS PROGRAM.
